Kept congressional staff informed about threats to religious freedom in France. The French Ambassador admits that small religious and spiritual "movements and practices" are being monitored as "sectarian drifts" and data on more than 200 have been updated and referred. This "system of reference" will not be published, but is made available to professionals such as judges, prosecutors, police and doctors. Such a system will inevitably lead to arbitrary restrictions on an individual's right to freedom of religion.

Also, worked with other members of an informal working group to lobby for full funding of the Second Chance Act in fiscal year 2011, which will help to increase public safety by improving reentry from prisons, jails, and juvenile facilities. The Second Chance Act was signed into law in April 2008.
